The meeting was called to order at 6:07 p.m.

Discussion:

**Motion #2:** To approve the March 2018 Treasurer's Report showing an all accounts balance of \$51,501.74 of which \$35,209.68 is solely PFO funds with \$1,400 in checks still pending withdrawal for the account. The motion was made by Melissa Franklin and seconded by Rene Cummings. The motion carried.

**Motion #3:** To approve up to \$80.00 for Student Recognition Committee to use to purchase four gift cards to be used for Student Awards. The motion was made by Donna Sawyer and seconded by Bev Andracchi. The motion carried.

**Motion #4:** To approve up to \$4,000.00 for the Class of 2018 Senior Awards. The motion was made by Bev Andracchi and seconded by Ken Bennett. The motion carried.

**Motion #5:** To approve the following Athletics Fundraisers to be chaired by Melissa Robert and/or Brooke DiFormato:

- Car Washes (one per month at local fire departments)
- 1000 Degrees Pizza Fundraiser
- Paint Night
- Spring Sports Events Concessions
- Spaghetti Dinner
- Pancake Breakfast
- September 2018 Youth Wrestling Tournament (TABLED AT THIS TIME)

The motion was made by Donna Sawyer and seconded by Stephanie Mazur to approve all of the fundraiser requests, with the exception of the Wrestling Tournament (Tabled). The motion carried.

**Motion #6:** To vote in the new PFO President, Melissa Franklin, Vice President, Lisa Therecka, and Treasurer, Ken Bennett, to fill impending 2018-2019 Officer vacancies. Donna Sawyer will

continue as PFO Secretary. The motion was made by Lisa Golden and seconded by Rene Cummings. The motion carried.

**Motion #7:** To pay \$1,500.00 for travel and hotel expenses for each of the four students who will be attending the Skills USA competition this year, amounting to a total PFO contribution of \$6,000.00. The motion was made by Rene Cummings, seconded by Bev Andracchi, with a third support from Melissa Franklin. The motion carried.

**Motion #8:** To pay \$240.00 Wastewater Treatment Technician Level 1 exam fee for a qualifying Senior Plumbing. The motion was made by Rene Cummings, seconded by Donna Sawyer, with a third support from Bev Andracchi. The motion carried.
